The Topic of the Conference

In 2007, when we launched the Mondigranti "adventure", we had the following three goals:

1. *To enhance the quality of scientific debate in the migration field, that in Italy is characterized by the relative novelty of the subject, its burning relevance for contemporary Italian society, and the intersection between scientific reflection, political debate and militant controversy;*
2. *To offer a forum for international scientific debate on migration issues; and*
3. *To provide opportunities for the publication of worthy articles, to stimulate scientific debate in the field and to provide a space for the exchange of ideas and research outcomes.*

A little more than a year after the first Conference in which we celebrated the tenth anniversary of the Journal, we want to propose another opportunity to recap the state of the art of the Migration Studies in Italy and in the European scenario. Thus, with the same spirit with which we have promoted “Mondi Migranti”, we especially want once again to offer an opportunity to those researchers who work within the Journal’s area of interest to share their findings and/or the research that they are currently developing. With this goal in mind, we launch this Call for Papers.

The conference will be held over one day and will be divided into three parallel thematic sessions. You are invited to present papers on the following topics:

- Refugees and reception measures;
- Immigration policies and territories: inclusion and exclusion;
- Work: insertion, promotion, exploitation;
- Migrant women;
- Civil society and solidarity with migrants and refugees;
- Xenophobia and racism;
- Migrants' new generations: school, work, social participation;
- Transnational and reunited families;
- Migrations, media and political communication;
- Immigration and religious pluralism;
- Migrant networks, associations and participation;
- Intercultural mediation and social work.

Submission guidelines

Interested contributors are invited to submit an abstract to: medi@csmedi.com by **10 January 2019**. The abstract must include:

- a. Author (surname, name and year of birth);
- b. Affiliation;
- c. Title of the paper with an indication of the topic for which one is applying;
- d. Summary of the paper (no more than 600 words, including references);
- e. Author's email address

Proposals can be presented and discussed in the following languages: Italian, English, French.

Authors will be notified by **February 10th, 2019** on the status of their submission.

The registration fee for the presentation will be **120€** that includes the subscription to *Mondi Migranti* for 2019.

According to the Editorial Board, some of the best papers will be selected for publication in the *Journal*.
